

AUSTRALIAN BAPTIST EDUCATION STUDENT LOAN APPLICATION FORM



STUDENT INFORMATION

Enrolled students who are Australian Citizens, holders of Permanent Humanitarian Visas or eligible New Zealand Citizens who wish to defer their fees, have access to ABE Tuition Finance.

TUITION FINANCE AGREEMENT

The Australian Baptist Education Inc. (ABE) will fully fund your tuition fees to Sheridan. ABE will pay the approved TFA amount directly to Sheridan and no cash will be made available. As part of the application you and your co-signer, parent, or legal guardian need to sign the Tuition Finance Agreement (TFA) document. Please make sure that you read the agreement and understand the terms and conditions thoroughly before accepting.

GRACE PERIOD

Students are automatically granted a grace period during your course. During the grace period, from class commencement, we do not ask for any payments.

REPAYMENT

The first repayment is scheduled 1 month after the course end date. Before such an event, ABE will provide you with a payment schedule detailing your future payment dates & amounts, along with the current balance. The repayment of the loan is spread over 10 years or 120 monthly instalments. Interest will accrue over the total length of the loan. The interest rate is tied to the Consumer Price Index. (CPI)

You may choose a repayment period that is shorter than ten years, but you will have to give written notice to ABE before the commencement of the repayments. Such a change will effectively raise your monthly instalments amounts. There will be no extra charge for repayments at an accelerated rate.

PAYMENT METHOD

All repayments shall be by direct debit. All repayments shall be made in Australian dollars.

LATE PAYMENTS

In the event that the monthly payment is not made when due, a late payment fee of AU\$20.00 will be applied, in addition to a monthly interest penalty of 1% on the amount of such late payments.

ABE will take the necessarily legal actions to recover the failure to make repayments as scheduled.
